## WHOLESALE TERMS AND CONDITIONS

Thank you for your interest in reselling Sea Level Sucks products. Below are the terms and conditions that apply to all of our wholesale contracts. To place an order, or for any questions, please contact us at [customerservice@sealevelsucks.com](mailto:customerservice@sealevelsucks.com) or 928-600-9086. In order to process any wholesale order, Sea Level Sucks must first verify a copy of your reseller tax identification number. We look forward to working with you. *BREATHE THIN AIR!*

### ORDER MINIMUMS:

Initial orders must reach a minimum of \$200. Repeat orders must reach a minimum of \$150.

### TERMS AND PAYMENT:

Initial orders must be paid for by a major credit card or business check. Major credit cards will be charged upon shipment of the order. Orders paid for by business check will be held until the check clears the bank and funds are deposited, at which time they will be shipped.

After three successful orders, and submission and acceptance of two credit references, subsequent orders will have the option of an invoice payable within 30 days of the ship date. If multiple orders are outstanding at one time, the first order must be processed and paid in full before subsequent orders will be processed.

### SHIPPING AND DELIVERY:

All orders will be shipped via USPS or FedEx with insurance and delivery confirmation at the expense of the buyer. Orders totaling \$500 or more will receive free shipping.

### RETURN POLICY:

Please contact Sea Level Sucks at 928-600-9086 to receive a return authorization number prior to shipping any returns. Returns are available if initiated within 10 business days of receipt, and all items are returned in their original condition. Return shipping is the responsibility of the buyer. All returns are subject to a 20% restocking fee on the first order and 15% on subsequent orders. Returns due to damage after delivery will not be accepted. No credit will be given for theft after delivery. If items are damaged during shipping, they will be replaced at no additional charge.

### ORDER CANCELLATION:

Orders may be cancelled without penalty within 5 business days of the order date or before the order has shipped, whichever occurs first. Cancellations after this period will be subject to a 10% restocking fee. Orders cancelled after shipment will be treated as a Return. Please see the return policy above.
